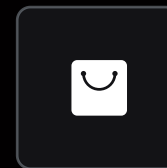
Strict compliance operation

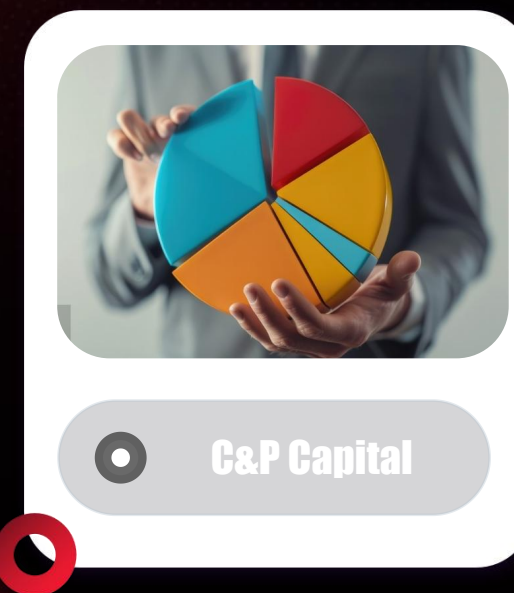


Risk Control and Compliance Management

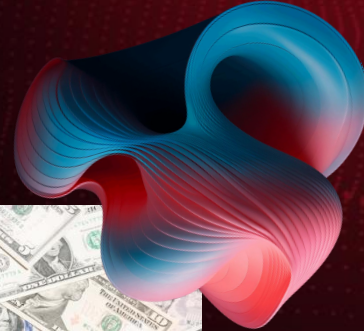

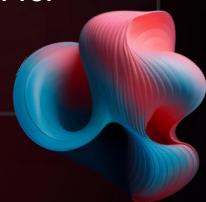

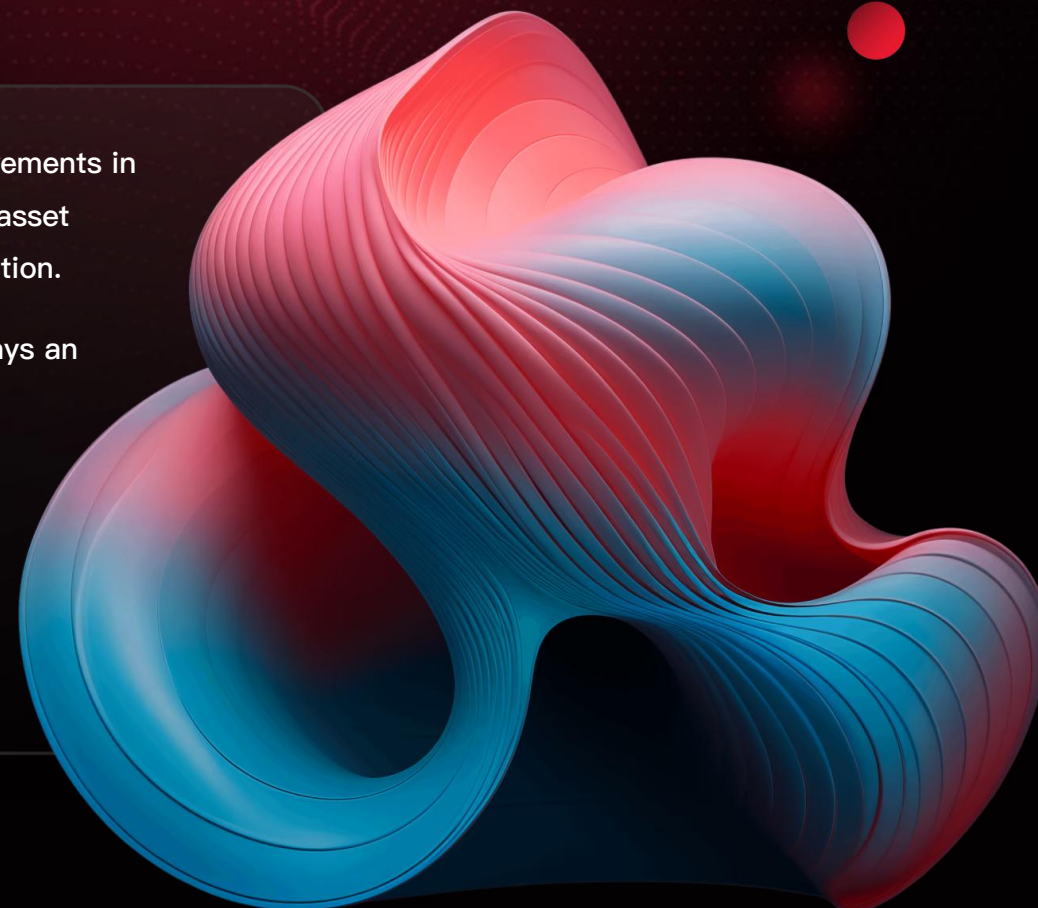
